### 12. Description & Justification

The Literacy & Non-Formal Basic Education (NFBE) Department in Punjab aims to provide basic education to out-of-school children (OOSC) and improve adult literacy, focusing on marginalized communities. According to 7<sup>th</sup> Population & Housing census 2023, 25.37 million children of the age band 5-16 years are out of school i.e. 10.5% of total population of Pakistan and 36 % of total population of same age bracket (5-16 Years). The number of OOSC (5-16 Years) in Punjab is 9.6 million, 27% of population of 5-16 years age population as below:

Above table shows that huge number of out of school children is present in the province which

requires deep focus and commitment to fulfil the target of 84.5% literacy in Punjab by 2030. A comprehensive multi-sectoral strategy accompanied by adequate budget shall also be required to bring the ratio of OOSC in single digit as first level of achievement.

There are demographical differences among the regions of Punjab which needs focus on region basis. The following region wise data of OOSC and Literacy Rate shows disparity of need in this regard:

### **Role of Literacy & NFBE Department**

Nevertheless, Literacy & NFBE Department is providing basic education, at present, to more than 600,000 out of school children through the establishment of 19,803 Literacy Institutions across Punjab through three development projects i.e **Central Punjab Non Formal Education Project, North Punjab Non Formal Education Project & South Punjab Non Formal Education Project**. Through these three projects, the department will be able to provide Non Formal Basic Education to more than 801,500 out of school children (OOSC) during the gestation of these projects. Practically, the department was able to enroll and mainstream approximately 10% of the total population of OOSC of the Province. The per annum cost per child is around Rs.5,000 as per approved projects. As can be seen, the model adopted by Literacy & NFBE Department provides the solution for bringing OOSC in to learning atmosphere at minimum cost.

To ensure equity and empowerment, the Department has made an effort to launch the Non-Formal Education intervention on the basis of regions due to inter regional disparities to address the issues specifically. The instant PC-I intends to focus in the 12 Districts which fall in the South Punjab. Under this project 8,745 Non-Formal Basic Education schools including 220 Non-Formal Education Elementary Schools will be established and targeted beneficiary group will be more than 345,400 out of school children within the age of 5-16 years in South Districts of Punjab. The Department shall focus on out-of-school children which are overage (7 to 16 years) for addition in NFBE & NFEE Schools under Central Punjab Non-Formal Education Project. However, the admission of 5 to less than 7 years learners shall be admissible only in the particular areas where free education facility has not been provided by the Government of Punjab.

The elementary program (Establishment of NFEEs) is designed specifically for OOSC and drop outs students of primary schools of less privileged areas where opportunities for middle level education are less. The program has been designed to impart technical skill at middle level. 13 skills trades (Basics of Hotel Management, Introduction to tourism, Basics of Graphic Design, Media Production, Fundamentals of cooking, Agriculture, Live-Stock, Internet of Things (IOT), Dress Making, Beautician, Applied Electrician, Plumbing and HVACR (Heating, Ventilation, Air conditioning, Refrigeration)) have been included and the curriculum has been designed in consultation with TEVTA, NAVTEC, PSDA, PCTB, PEC, QAED etc. Moreover, this is an Accelerated Learning Program (ALP) designed to impart middle education to OOSC in 18 months instead of 36 months.

#### **14 Objectives of the Project**

- Impart primary & Elementary education to out-of-school children via non-formal approach (alternative learning pathways).

- Special focus on disempowered/neglected segments of society, especially in southern districts, tribal area inhabitants, women and rural youth on a priority basis.
- Contribute towards achievement/realisation of sustainable development goals (SDGs) concerning primary education.

#### 15 **Rational of 1<sup>st</sup> Revision of Project**

The 1st revision of Central Punjab Non Formal Education project has been made due to the following reasons:

- **Increase in NFE Teachers monthly remuneration**  
The Punjab Cabinet in its 22nd meeting held on 14-01-2025 has decided to increase the NFE teachers' remuneration from Rs12,500/per month to Rs.20,000/per month w.e.f P&D proposed date 01-01-2025.
- **Increase in Project Cost**  
The Project Cost has been increased from 5341.811 million to 7,555.286 million due to increase in monthly remuneration of teachers from Rs.12,500 to Rs.20,000 per month.

#### 16 **Scope of the Project**

##### **NFBES Teachers, Schools & Learners**

- 8,525 Non-formal Basic Education Schools (NFBES) shall be established.
- 8,525 Non-formal Education teachers shall be engaged.
- 75% (minimum) shall be female teachers.
- 341,000 Non-Formal Education learners shall be the beneficiaries.
- More than 50% beneficiaries (learners) shall be girls
- 60,000 learners shall be Primary Pass-outs/promoted.

##### **NFEES Teachers, Schools & Learners**

- 220 Non-Formal Education Elementary Schools (NFEES) shall be established.
- 440 Non-Formal Education teachers shall be engaged.
- 75% (minimum) shall be female teachers.
- More than 50% beneficiaries (learners) shall be girls.
- 4,400 shall be Elementary level beneficiaries
- 3,520 learners shall be Elementary pass-outs/promoted

##### **Skill Program for Elementary School learners**

PCTB has approved Accelerated Learning Program (ALP)-Elementary Curriculum of Literacy & NFBE Department on 20-09-2024 for Middle-Tech program. Further, the textbooks of ALP-Middle/Middle-Tech has also been approved from PCTB in BOG meeting held on 10-02-2025. This includes 13 trades ((Basics of Hotel Management, Introduction to tourism, Basics of Graphic Design, Media Production, Fundamentals of cooking, Agriculture, Live-Stock, Internet of Things (IOT), Dress Making, Beautician, Applied Electrician, Plumbing and HVACR (Heating, Ventilation, Air conditioning, Refrigeration) out of which one trade will be taught in individual elementary school.

### Teachers Hiring Criteria

- **NFBES Teacher:** Intermediate (minimum 50% obtained marks)
- **NFEES Teacher:** Graduation (minimum 50 % obtained marks)
- **Remuneration:** Rs.16,000/- per month + Rs.4,000/- per month in lieu of utility & mobile SIM data charges.
- **Gender:** Male / Female / Transgender.
- Job capability test and subsequent interview of successful potential candidates and recommendation of suitable candidates by a committee strictly in accordance with the policy/ criteria as notified by the L& NFBED.
- The classes will be held 06 days a week, 04 hours a day. The total period of Primary education is 48 months (Katchi to Grade-5) while for elementary education it is 18 months.

### Learners Criteria

- Out of School Children
- Formal School Dropouts
- 05 – 16 Years (in particular Areas where free education facility by government is not being provided)
- 07-16 Years (in general shall be observed)
- Male, Female & Transgender.
