### 12. PROJECT BRIEF DESCRIPTION

The CM Punjab Laptop Program is a targeted initiative aimed at providing laptops to talented students in public sector higher education institutions (HEIs) across Punjab. This project seeks to bridge the digital divide, empower students through technology, and enhance their academic experiences. It includes a comprehensive approach involving student surveys, laptop procurement, organized distribution, feedback collection, and continuous monitoring and evaluation.

Under original approval, this program/project initially aimed at provision of laptops approximately 39,200 students which is being extended upto 112,000 at their respective institutions currently studying at public sector educational institutes in Punjab. The list of total students' strength of 558,832 studying BS/MS/MBBS/Engineering programs in the Public Sector colleges and universities will be prepared by the respective institutions as per laid down criteria, approved by Steering Committee.

- Digital empowerment and improved access to educational resources.
- o Reduction of socio-economic disparities and promotion of equal opportunities.
- Collaboration with the local ICT industry for economic growth and entrepreneurship.
   Investment in human capital and positioning in the global ICT industry.
- Enabling students to equip with skills to compete with the standards of other countries at global and regional level.

#### 13. PROJECT OBJECTIVES:

The CM Punjab Laptop Program encompasses several objectives:

- i. Empowerment of Students
- ii. Enhancement of Educational Opportunities
- iii. Digital Inclusion
- iv. Skill Development
- v. Academic Support
- vi. Bridging the Digital Divide
- vii. Transparency in the Selection Process
- viii. Long-Term Impact on the academic and professional development of students.

### 14. REASONS OF 1st REVISION:

Three main reasons for revision of the PC-I:

- i. Procurement of 2,800 additional laptops by purchasing:
  - a. 2,000 laptops from savings (Rs.565.656 million) on account of reduced bid cost
     @ Rs.0.235 million per unit against the approved PC-I's unit cost of Rs. 0.250 million.
  - b. 800 laptops from Rs.135 million allocated against the Software and other heads in the original PC-I.
- ii. The Provincial Cabinet in its meeting held on 11.02.2025 has approved procurement of 70,000 additional laptops with additional cost of Rs.16.5 billion.
- iii. Increase in operational cost of the project.
