#### 12. Approval History of the Project:

➤ The scheme was originally approved as an umbrella scheme comprising of 07 subprojects by the PDWP in its meeting held on 01.09.2023 at a total cost of Rs.1,063.161 million (Capital) with gestation period up to 30.06.2025 with the following directions for preparing sub-projets;

a.	Sardar Begum Teaching Hospital	Rs.96.916 Million
b.	Said Mitha Hospital, Lahore	Rs.37.650 Million
c.	Mian Munshi Hospital, Lahore	Rs.154.169 Million
d.	Ghulam Muhmmad Hospital, Faisalabad	Rs.71.063 Million
e.	DG Khan Teaching	Rs.311.060 Million
f.	Lady Aitchison Hosptial, Lahore	Rs.185.021 Million
g.	Nawaz Sharif Hospital, Yakki Gate Lahore	Rs.207.282 Million

i. SHC&ME Department would prepare PC-Is of the component as sub-projects within the approved cost and scope for approval from the competent forum while ensuring that there is no duplicity and overlapping of activities under sub-projects.

- ii. SHC&ME Department would reduce contingency from 3 % to 2 % and delete 1% horticulture charges at the time of preparation of sub-projects.
- iii. The responsibility of rates, specifications and design would rest with Administrative Department and the authority competent to accord technical sanction.
- iv. Pictorial evidences before start of work shall be made part of the PC-I, and pictorial evidence after completion of work shall also be ensured.
- v. SHC&ME Department shall seek permission from ECP prior to execution of the sub-projects
- ➤ Subsequently, all 07 separate PC-Is of the civil component were approved by the DDSC in its meeting held on 28.09.2023 as sub-projects at a total cost of Rs.1,094.520 million (Capital).
- ➤ After that, 1<sup>st</sup> revision of 02 sub-projects were approved by the DDSC and 03 other sub-projects were approved by the PDWP at total revised cost of Rs.2,267.485 million (Capital). Resultantly, total cost of umbrella PC-I was enhanced from Rs.1,094.520 million (Capital) to Rs.2,267.485 million (Capital).
- ➤ Revised cost estimates of 06 schemes out of total 07 sub-schemes approved under the umbrella project, were presented before Caretaker Provincial Cabinet in its 35<sup>th</sup> meeting dated 10.01.2024. The Cabinet committed its full support for provision of requisite funding to complete the work within approved scope / cost / timeline determined by the relevant competent forum.
- Now, the SHC&ME Department has submitted 1<sup>st</sup> revision of the umbrella scheme at a total cost of Rs.2,267.485 million (Capital) with gestation period up to 30.06.2025.

PC-I of the instant scheme was discussed in Pre-PDWP meeting held on 10.03.2025 under the Chairmanship of Member (Health), P&D Board wherein said scheme was discussed in detail. In response to the observations / deliberations of Pre-PDWP meeting, SHC&ME Department has submitted annotated replies which are given below;

Accordingly, after detailed discussion, revised approvals were accorded by the DDSC. During pre-PDWP meeting, the Chair inquired about physical progress of the projects so far. It was informed that out of total 07 hospitals 02 hospitals namely "Said Mitha Hospital, Lahore and Ghulam Muhammad Hospital, Faisalabad" had already been completed and handed over. Furthermore, the physical progress of the remaining hospitals was more than 95% except "Sardar Begum Teaching Hospital, Sialkot" which was around 80%. The MS, Sardar Begum Teaching Hospital, Sialkot stated that remaining funds would be required to complete the project within approved gestation period. The Chief (SH&ME), P&D Board pointed out that revision of the following 02 schemes i.e. "Lady Aitchison Hospital, Lahore

and Nawaz Sharif Hospital Yakki Gate, Lahore" was approved by PDWP with gestation period upto 31<sup>st</sup> December, 2024 however, the SHC&ME Department has submitted the revised PC-I with extended gestation period upto 30<sup>th</sup> June, 2025. Additional Secretary (Dev.), SHC&ME responded that both the schemes were physically completed upto 98% and only finishing work was in progress which would be completed soon, therefore, extension in gestation period upto 30<sup>th</sup> June, 2025 was requested in revised PC-I.

## 19. Recommendation:

The umbrella scheme at revised cost of **Rs.2,267.485 million** (Capital) with gestation period till 30.06.2025 is placed before the PDWP for its consideration.
